Willie Blount Papers McClung Historical Collection

Willie Blount, son of Jacob Blount and his second wife Hannah Salter Baker, was born on April 18, 1768, in Bertie County, North Carolina. Willie (pronounced Wiley) moved to the Tennessee area about 1790 to serve as the private secretary of his half-brother William Blount, who was governor of the Southwest Territory. In 1794 he received his license to practice law. After 1802 he moved from Knoxville to Montgomery County, Tennessee. He served one term in the Tennessee legislature and was elected governor of Tennessee in 1809. He was elected to additional terms in 1811 and 1813. Willie Blount was noted for his support of General Andrew Jackson's campaign against the Creek Indians. He died on September 10, 1835. (For additional information about Willie Blount, see *The French Broad-Holston Country*)

This collection ranges in date from 1801 to 1815. It includes thirty-one documents, with the Willie Blount correspondence starting in 1809 and ending in 1815. Correspondents include Andrew Jackson, Henry Dearborn, R. J. Meigs writing from the Highwassee (Hiwassee) Garrison, Cherokee Chief Glass writing from the Tellico Blockhouse, Archibald Roane, and John Sevier. Subjects include Native Americans, Cherokee Indians, treaties, trading, crimes, and land. Also included is an 1808 'Address to the Cherokees' by Thomas Jefferson.

An item by item, chronologically arranged finding aid was prepared for this collection. 3 doc. Typed transcriptions are available for ten of the documents. They are located in the final folder of the collection.
